

# SPOTLIGHT DANCE

## ENROLLMENT CONTRACT (9/5/2020)

Please read this enrollment contract carefully, as these policies will be strictly followed and exceptions or changes cannot be made for any reason.

### **Tuition & Fees**

- Dance Tuition is based on the dance year and **not by the class or month**. 9 equal payments are due at the first class of each month (September through May). Payments received after the 15th of the month will be assessed a \$10 late fee.
- The Registration Fee and Tuition Payment for all classes are due prior to starting classes.
- There is no tuition proration or make-up classes for any missed days, holidays, rehearsals, inclement weather, or school vacations.
- If tuition is more than two weeks overdue, the student will only be allowed to observe class. If tuition is more than four weeks overdue the the student will not be able to enter the class.

### **Payment Methods**

Acceptable payment methods include cash, check, MasterCard, Visa and Discover. Returned checks will be assessed a \$35 service charge. A receipt will be provided for all payments.

### **Termination of Enrollment**

A written notice is required in order to terminate enrollment at Spotlight Dance. Verbal, telephone, fax, email, text, or other forms of electronic communication will not be accepted. The Termination Notice is available on our website or in the studio.

### **Refunds**

A full refund will be given for any class that is cancelled due to low enrollment. Payments for monthly tuition, summer tuition, registration fees, competition fees, costume deposits, recital tickets, merchandise, and all other costs not listed here are not refundable. Personalized merchandise is not exchangeable. Other merchandise, if new and unused may be exchanged for another item.

### **Photo/Video Notification**

By registering with Spotlight Dance I grant Spotlight Dance the right to use images, photos, and videos taken during class or other Spotlight Dance activities for promotional or advertising purposes. Example uses include, but are not limited to, the Spotlight Dance website, Spotlight Dance Facebook site, brochures, and advertisements.

### **Recital Information**

An annual recital will be held at the end of the Dance Season at a local school. Participation in the recital is optional, and will require costume and recital fees for those choosing to participate. Little Stars students will have a small recital held in the classroom during their last scheduled class. Information about the annual recital will be sent home later in the year.

### **Lost or Stolen Items**

Spotlight Dance will not be responsible for lost or stolen items of any kind.

### **Insurance**

Spotlight Dance does not carry medical insurance for its students. It is required that all student's be covered by their own family insurance polices and if injury occurs, it is understood that the families own insurance policy is your only source of reimbursement.

### **Release of Liability**

As a condition of acceptance in dance classes, I hereby covenant and agree to hold Spotlight Dance harmless and forever indemnify it, and its owners, and its agents from any and all liability arising from injuries which my child should sustain while on the premises occupied by Spotlight Dance or while attending Spotlight Dance activities such as parades, competitions, demonstrations, out of town trips, shows, etc.

### **Medical Emergency**

The undersigned gives permission to Spotlight Dance, its owners and agents to seek medical treatment for the participant in the event they are not able to reach a parent or guardian or an emergency contact person.

### **Guidelines**

### **Spotlight Branding**

Use of all Spotlight branding and derivates including ("Spotlight", "Spotlight Dance", "Spotlight Dance Company", "Spotlight Dance Company Gems(tones)", "Spotlight Gems(stones)", "Gems(tones)", "Pearls", "Rubies", "Diamonds", "Sapphires", "Emeralds", "Spotlight Competition Team", etc) and the Spotlight Logo is prohibited. An example prohibited use is making custom attire (shirts, jackets, pants, sweatshirt, patches, bags, etc.) containing any for the words or phrases listed above and/or the Spotlight logo. In the simplest terms no one can use the Spotlight name or logo for any purpose without express written consent.
